

# 1. Eligibility Requirements

This Contest is open to legal residents of Pennsylvania and Maryland who are 18 years of age or older at the time of entry. Employees of Siegman Forced Air Systems dba Siegman HVAC ("Siegman HVAC"), their immediate family members and persons living in the same household are not eligible to participate.

#### 2. Contest Period

The Contest begins on June 1, 2024, at 12:01 a.m. and ends on July 1, 2024, at 11:59 p.m. (the "<u>Contest Period</u>"). Siegman HVAC must digitally receive any entry during the Contest Period to be eligible. Siegman HVAC will announce the winner on July 4, 2024.

#### 3. How to Enter

To enter the contest, participants must:

- Submit a written essay of at least 250 words describing why they believe the nominee is worthy of winning the contest. The essay should be compelling and include:
  - Need and Impact: Describe the nominee's current HVAC situation and the impact that receiving a new system would have on their life. Explain any financial hardships, health concerns, or other significant reasons why the nominee needs a new HVAC system.
  - Patriotism: Highlight any acts of service, community involvement, or other demonstrations of patriotism that the nominee has shown. This could include military service, volunteer work, or contributions to the local community.
  - Quality of Submission: Ensure the essay is well-written, clear, and persuasive. Including
    personal stories, specific examples, and emotional appeals can help make the case more
    compelling. Al generated content will not be accepted.

- To complete your official entry, you must complete each step listed here:
  - 1. Complete the Microsoft Form that will be sent to the email you provide on the interest form that includes your essay.
  - 2. Post a minimum of four (4) photographs and/or one video lasting 10 seconds or more that support your written essay submission by posting to your individual Facebook account with the #NominateANeighbor and tagging @Siegman Forced Air Systems, Inc
  - o 3. Receive a confirmation number via email before the closing of the contest.

#### 4. Winner Selection

A panel of three (3) judges selected by Siegman HVAC will review and assess all eligible entries. The winner of the Contest will be chosen based on the following criteria:

- 1. Need and Impact (30%)
- 2. Service to the ideals of Patriotism (40%)
- 3. Quality of Submission (30%)

The decision of at least the majority of the panel is final and binding. Each judge will assign a value of 1-10 for each category. The weighting criteria will then be applied to each category score to arrive at a final score. Should the scoring result in a tie, a fourth judge shall be appointed who will then evaluate the tied entries in a ranked order thus selecting the winner.

#### 5. Prizes

The winner of the Contest will receive a new HVAC system installed by Siegman HVAC. The selection of the equipment to be installed is at the sole discretion of Siegman HVAC. Some homes may not qualify. There is no cash value alternative for the winner of the Contest. The prize is non-transferable, and no substitution will be made except at the sponsor's sole discretion.
